- 2. HOW TO ENTER:** Holland America Line's Half Moon Cay 20th Anniversary Sweepstakes ("Sweepstakes") begins at 12:00 A.M. Pacific Time (PT) on August 14, 2017, and ends at 11:59 P.M. PT on February 28, 2018 (the "Entry Period"). Entrants may submit an entry online or by mail.
